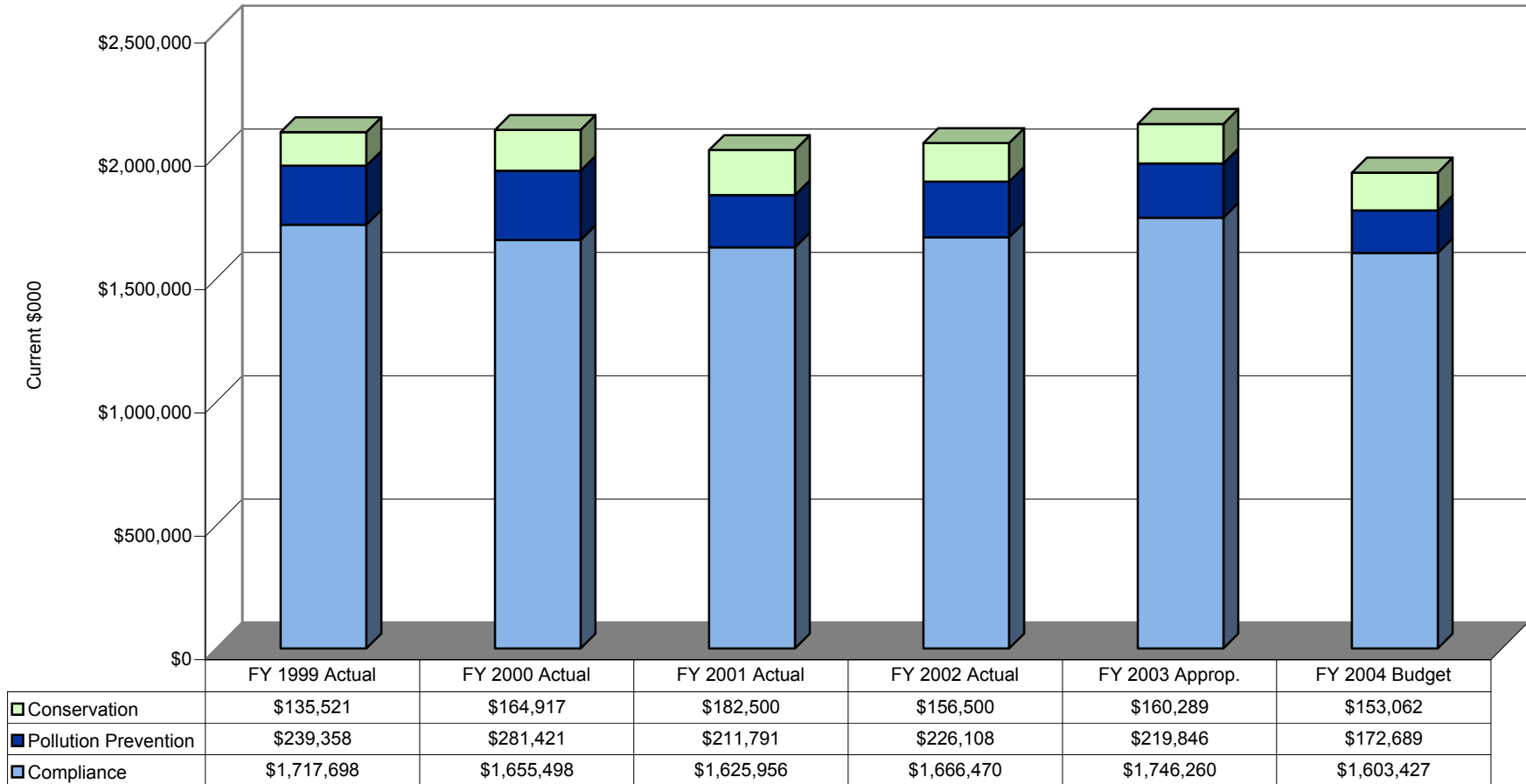
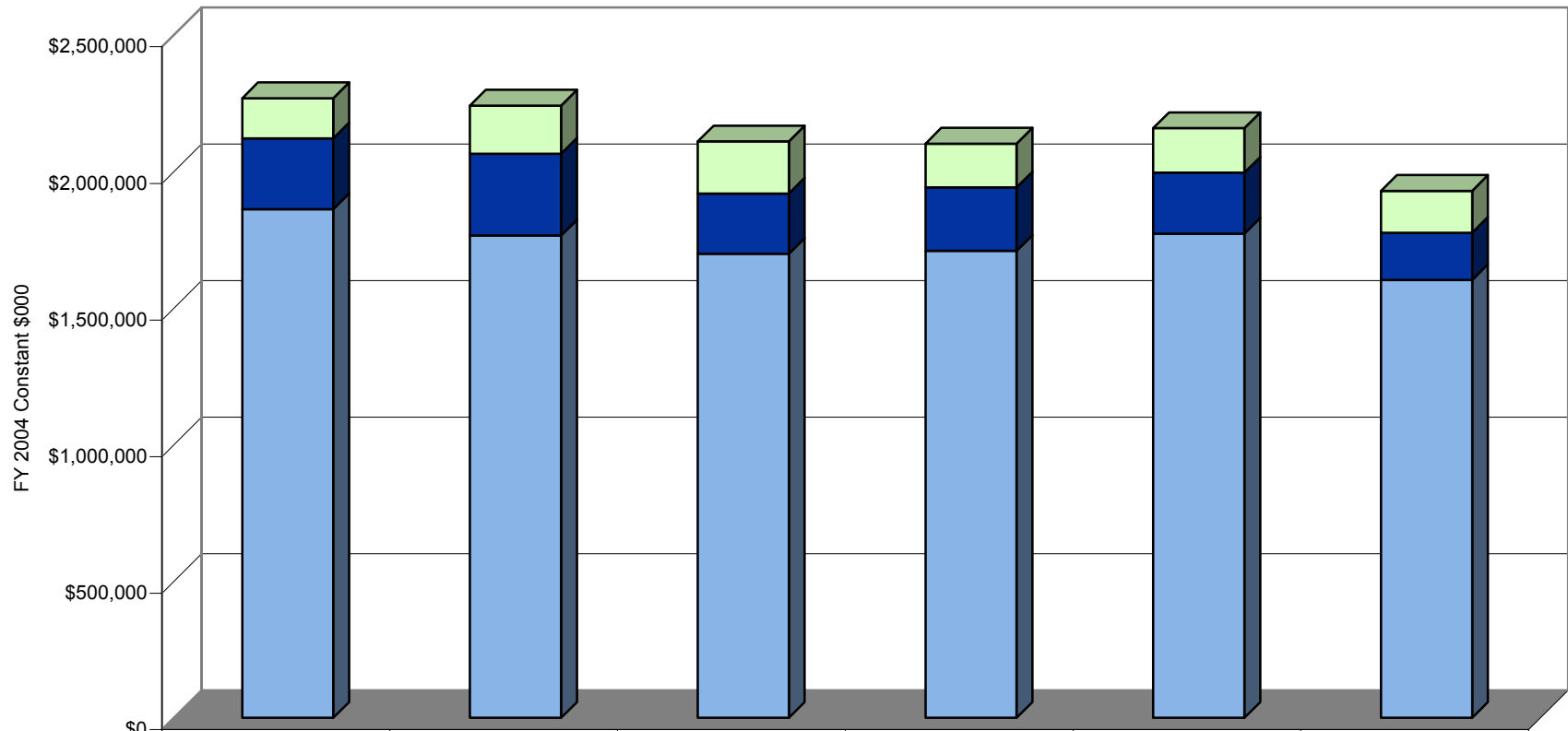
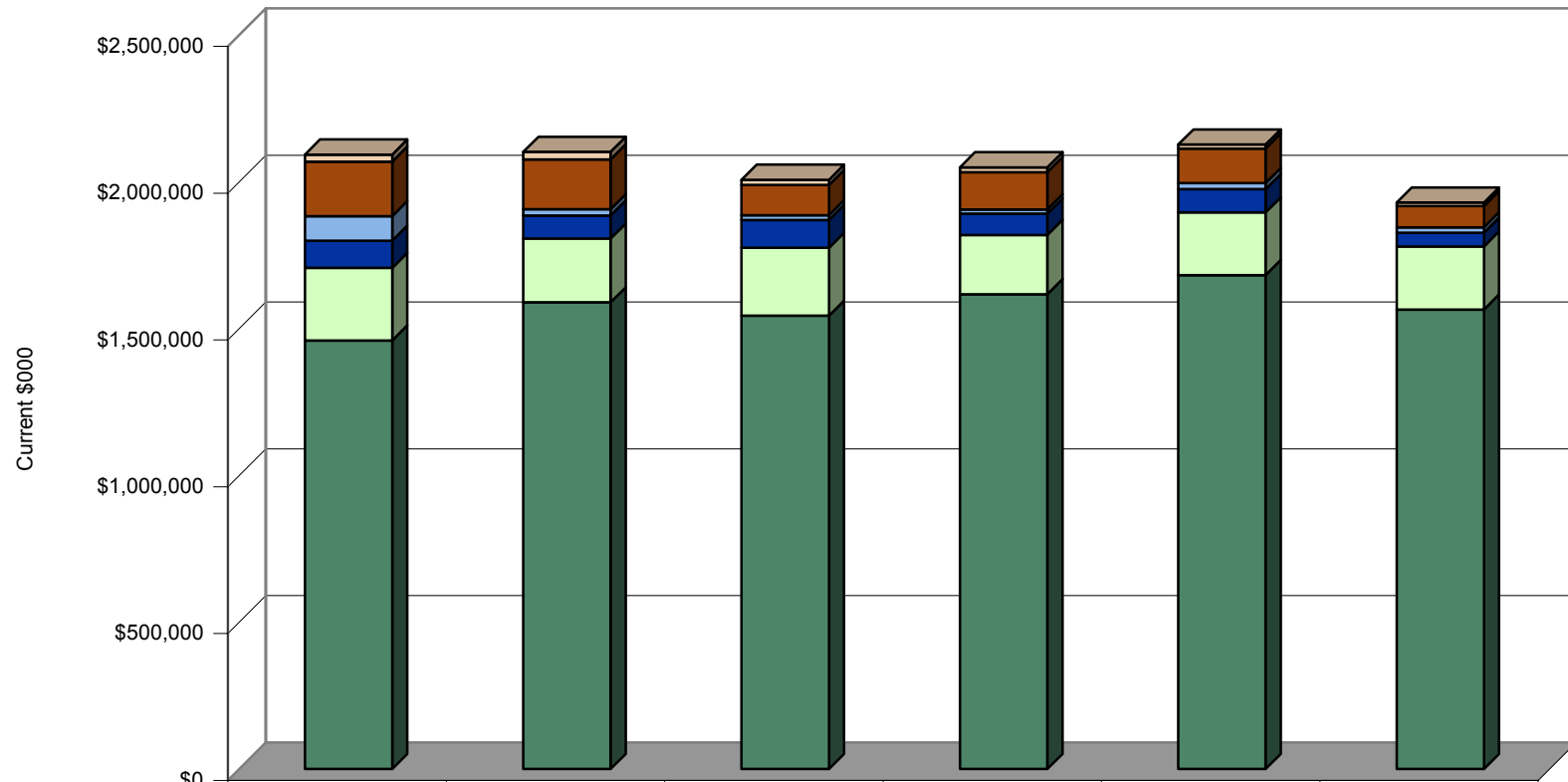

(FY 2004 Constant \$000)

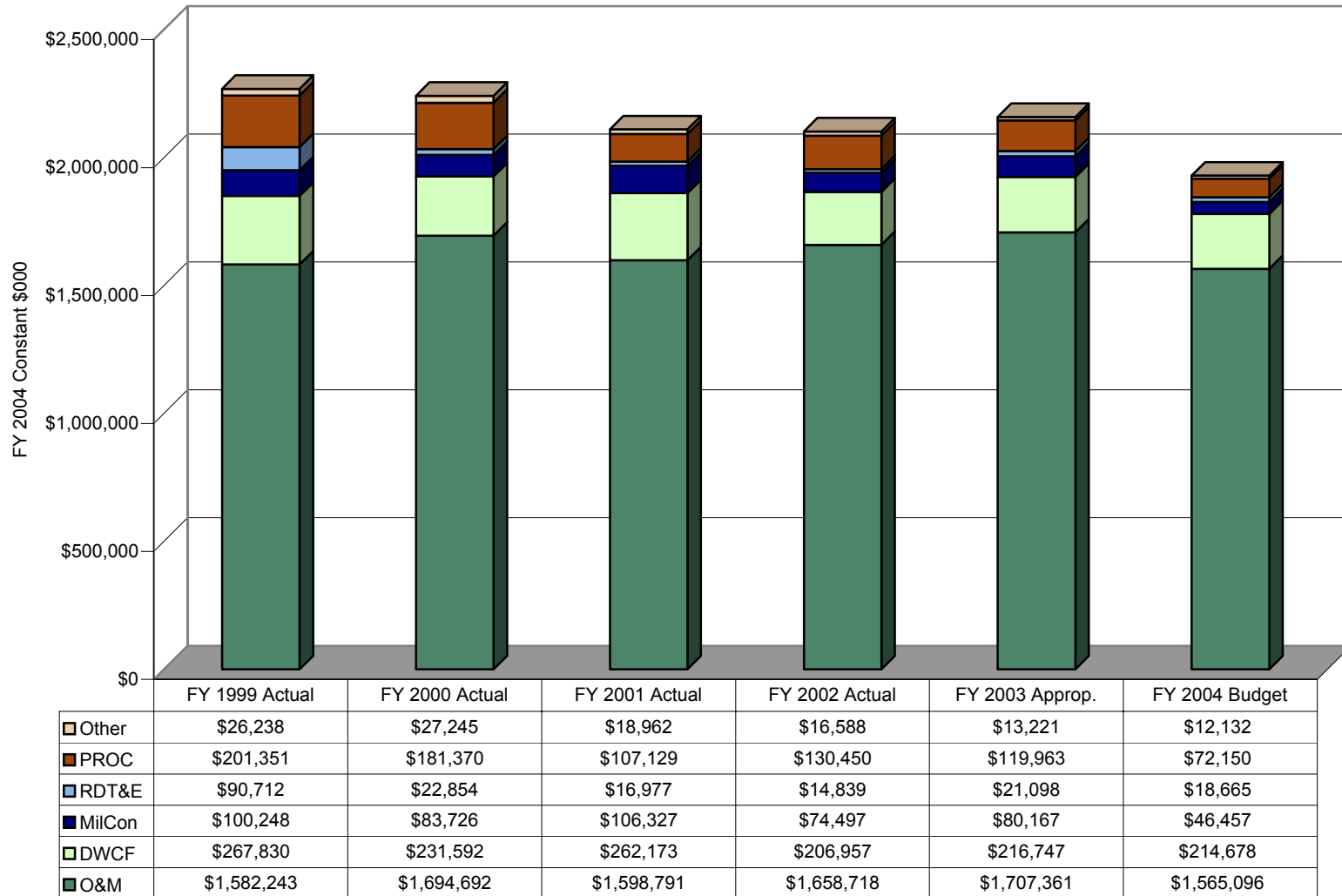

(Current \$000)

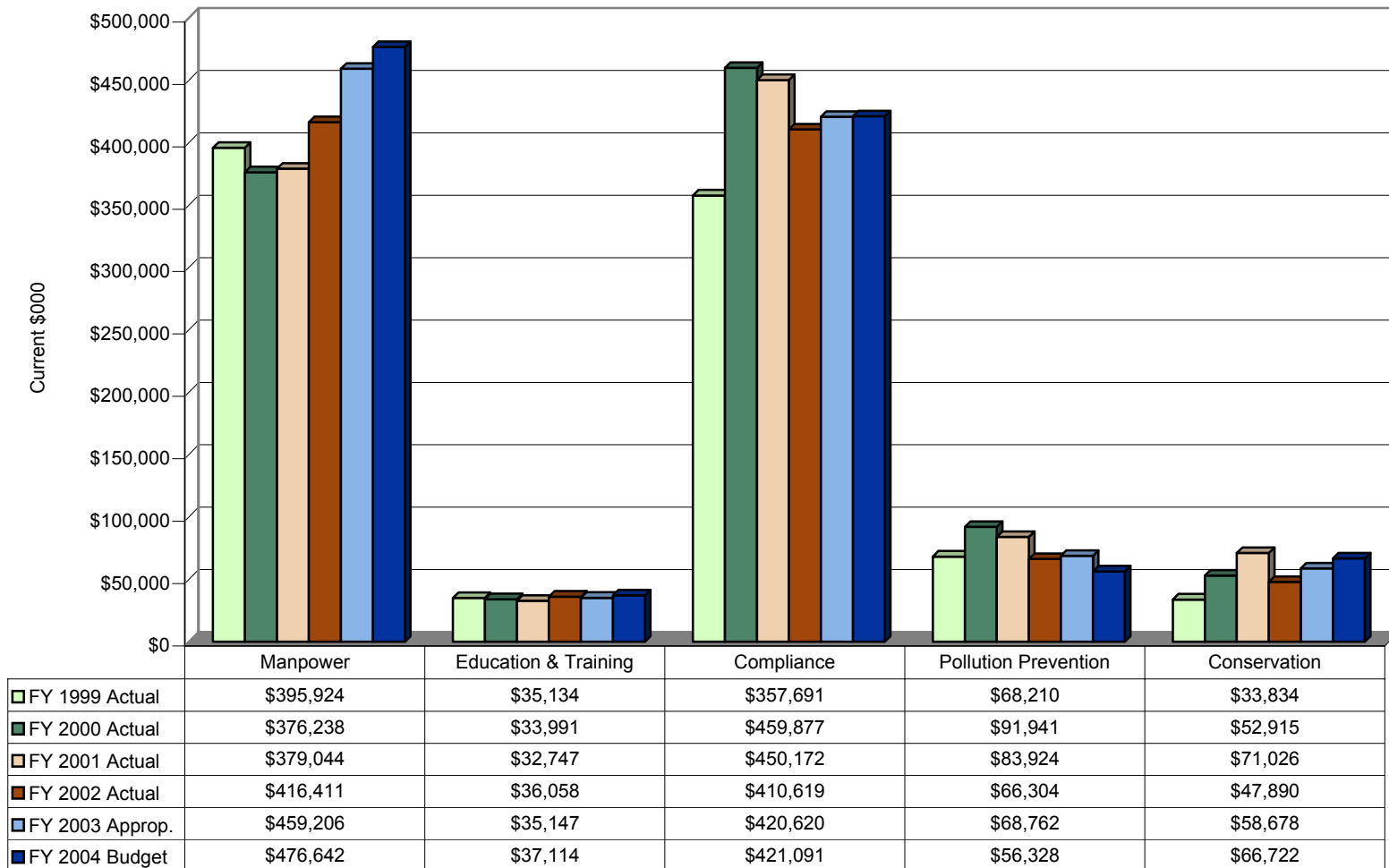

(FY 2004 Constant \$000)

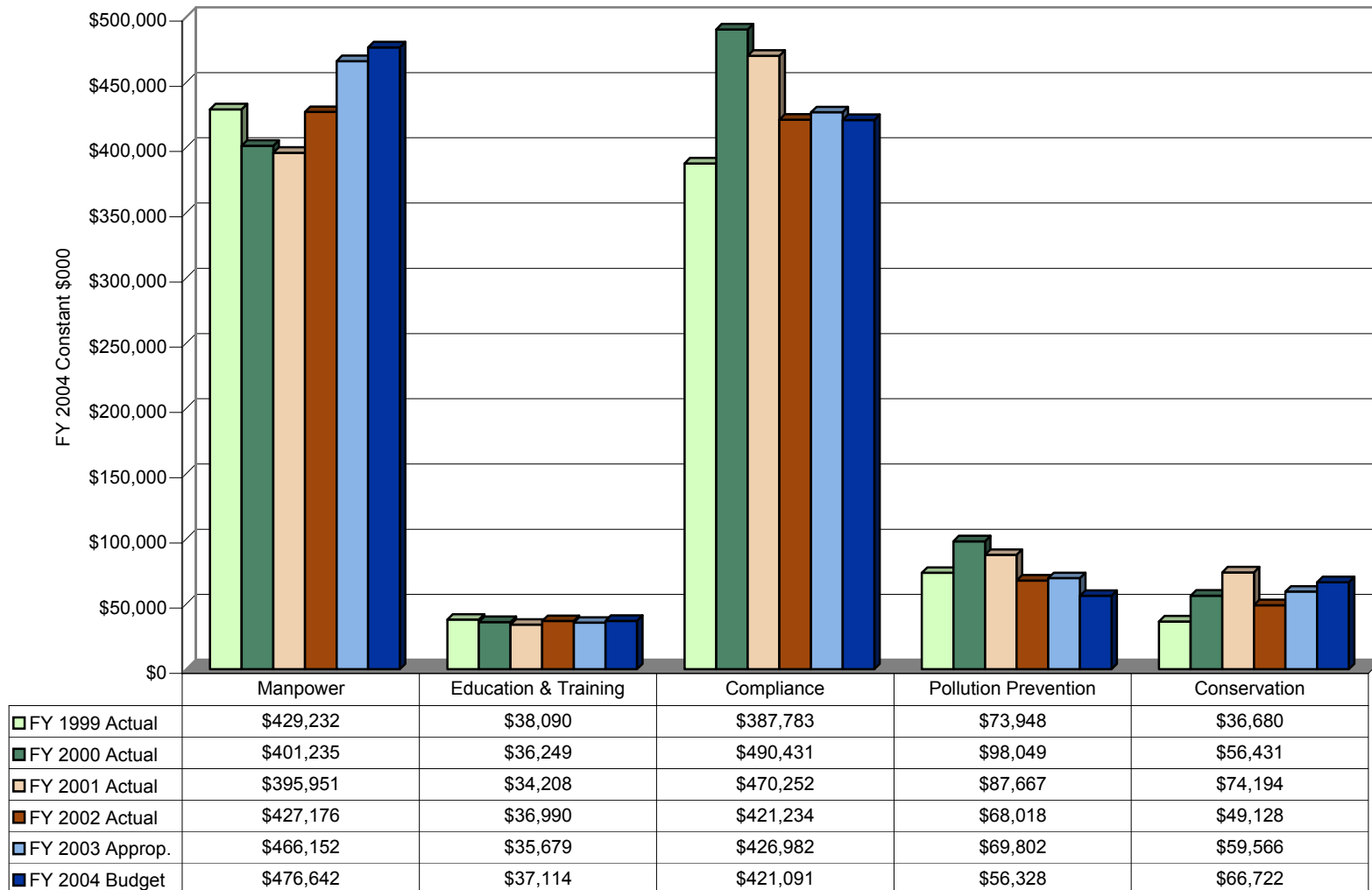

(Current \$000)

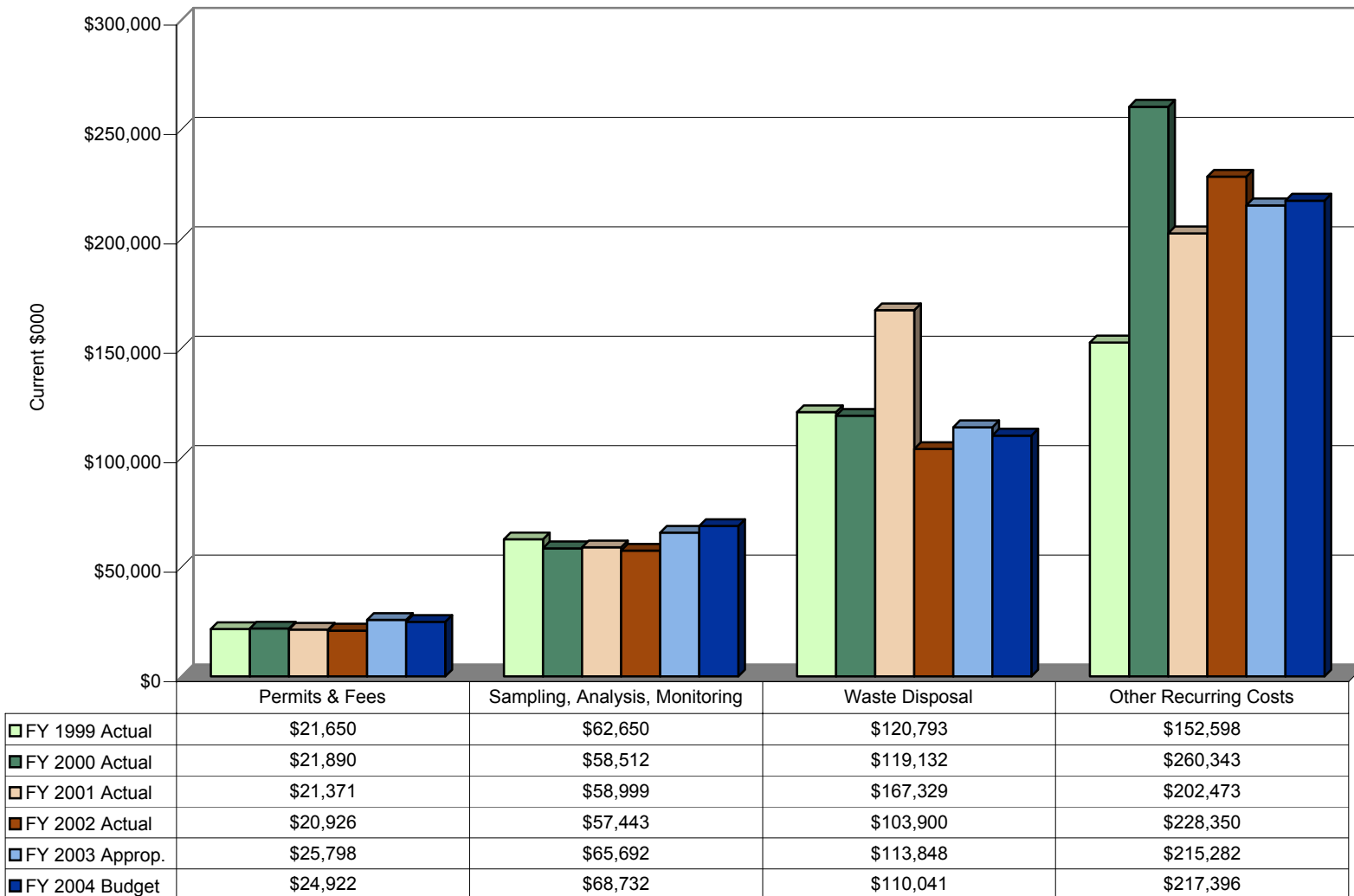

(FY 2004 Constant \$000)

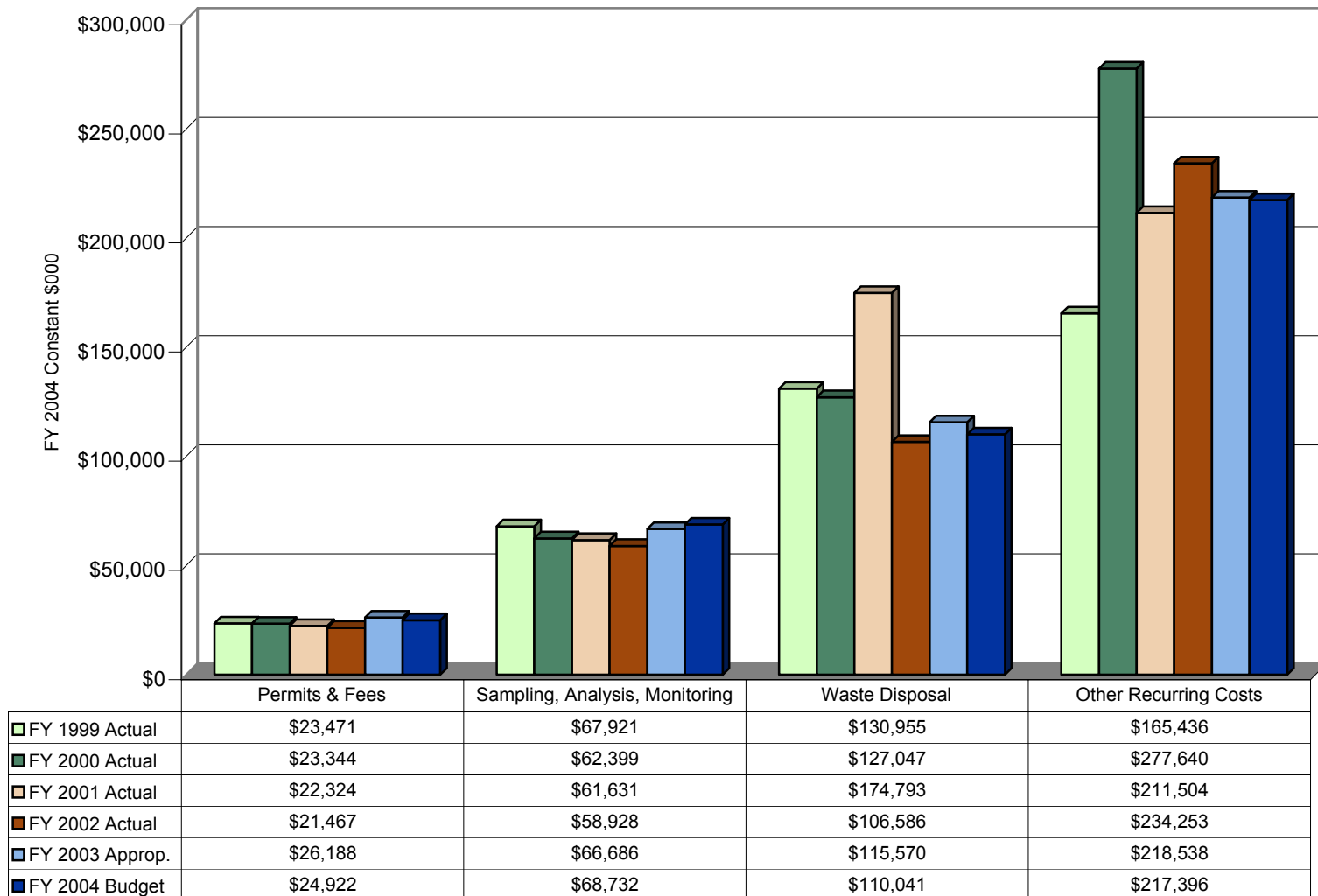

(Current \$000)

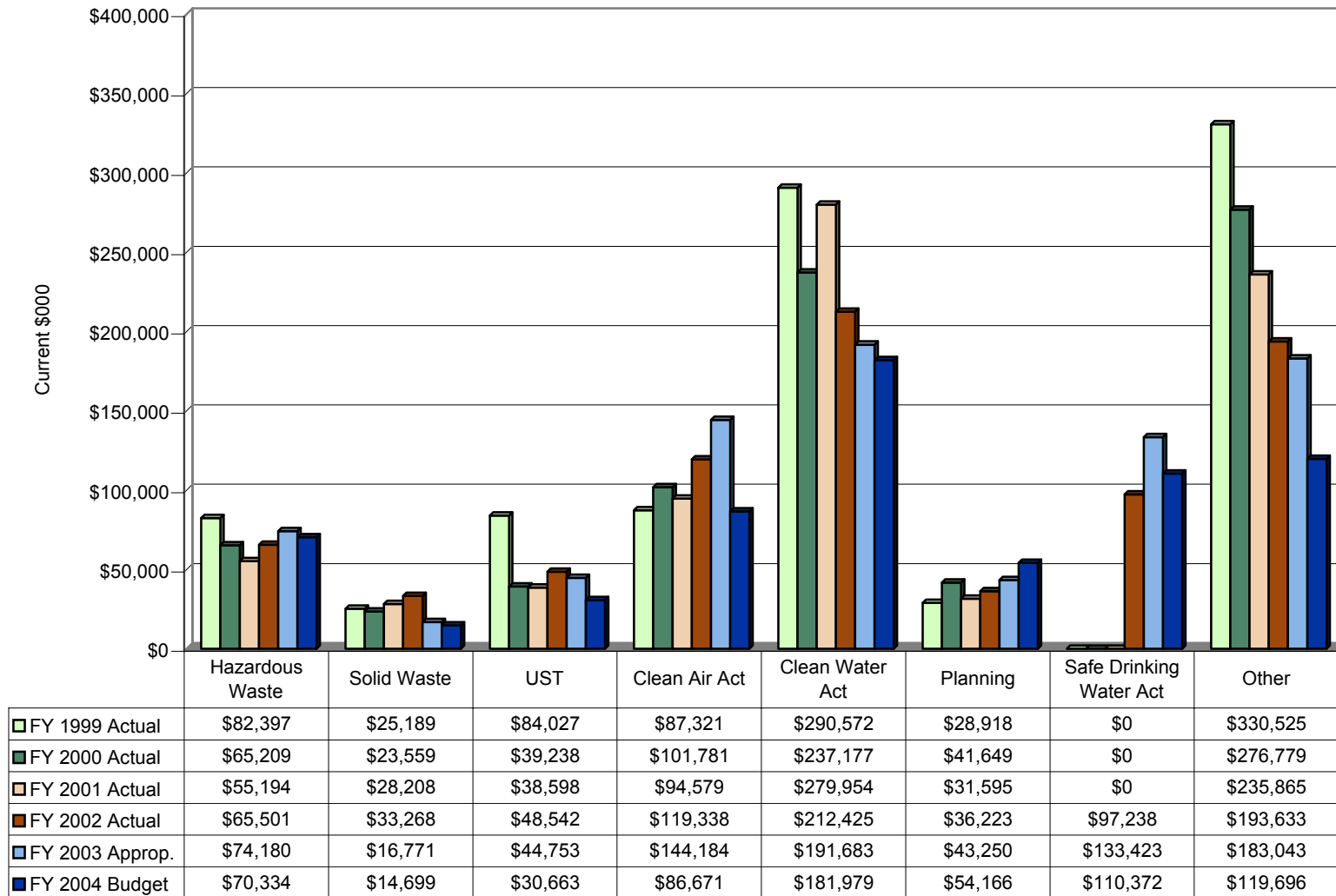

(FY 2004 Constant \$000)

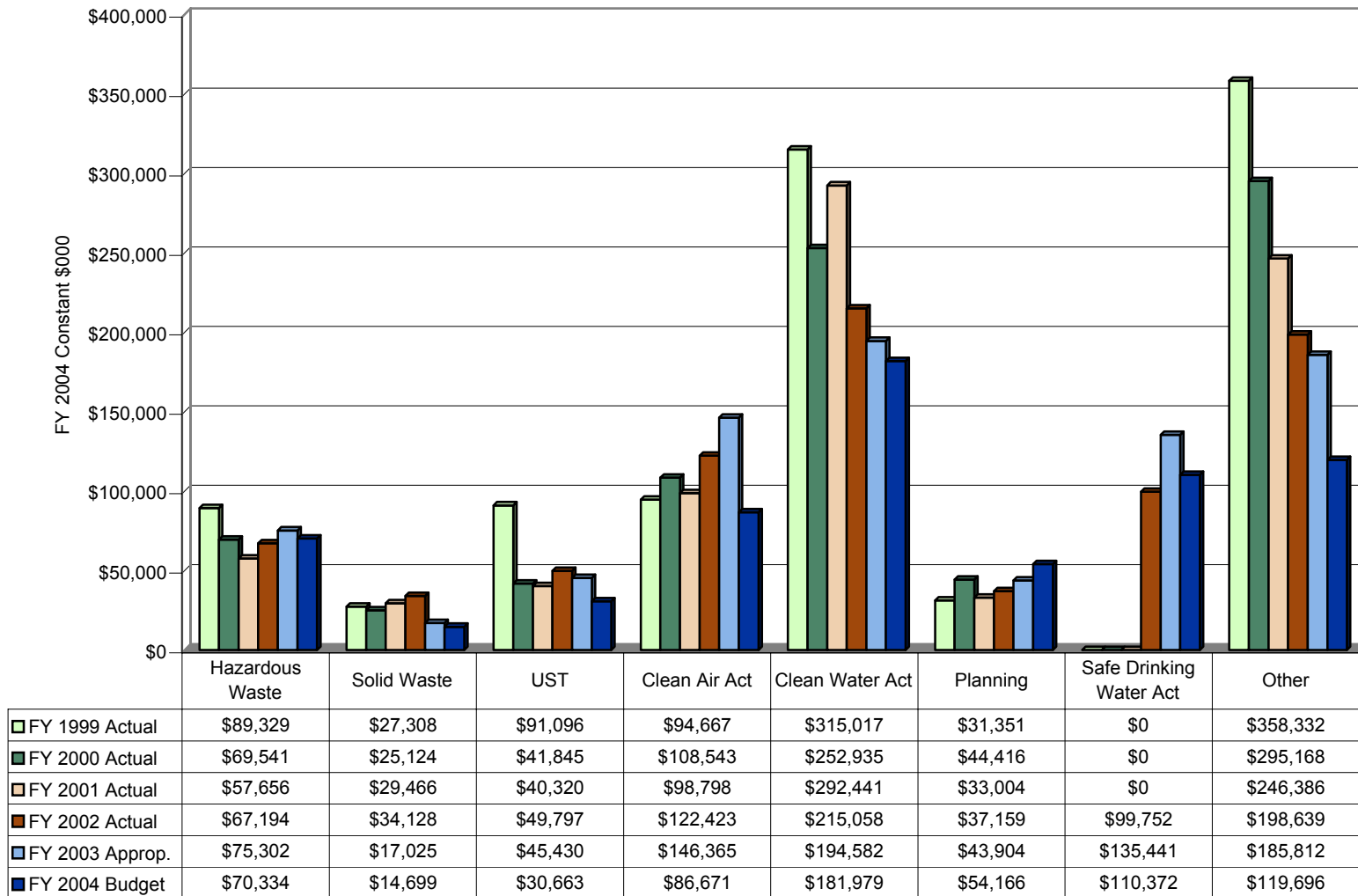

(Current \$000)

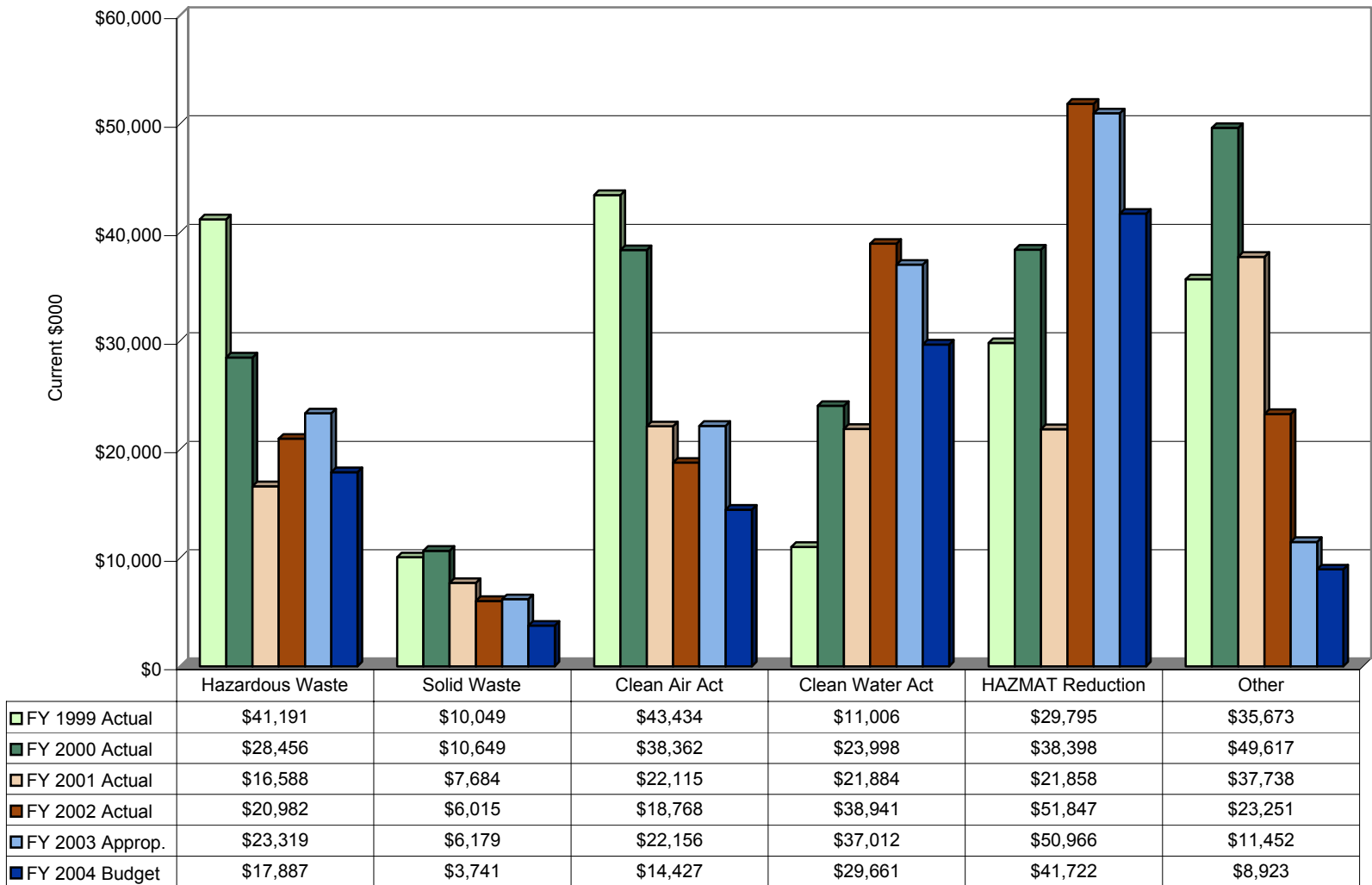

(FY 2004 Constant \$000)

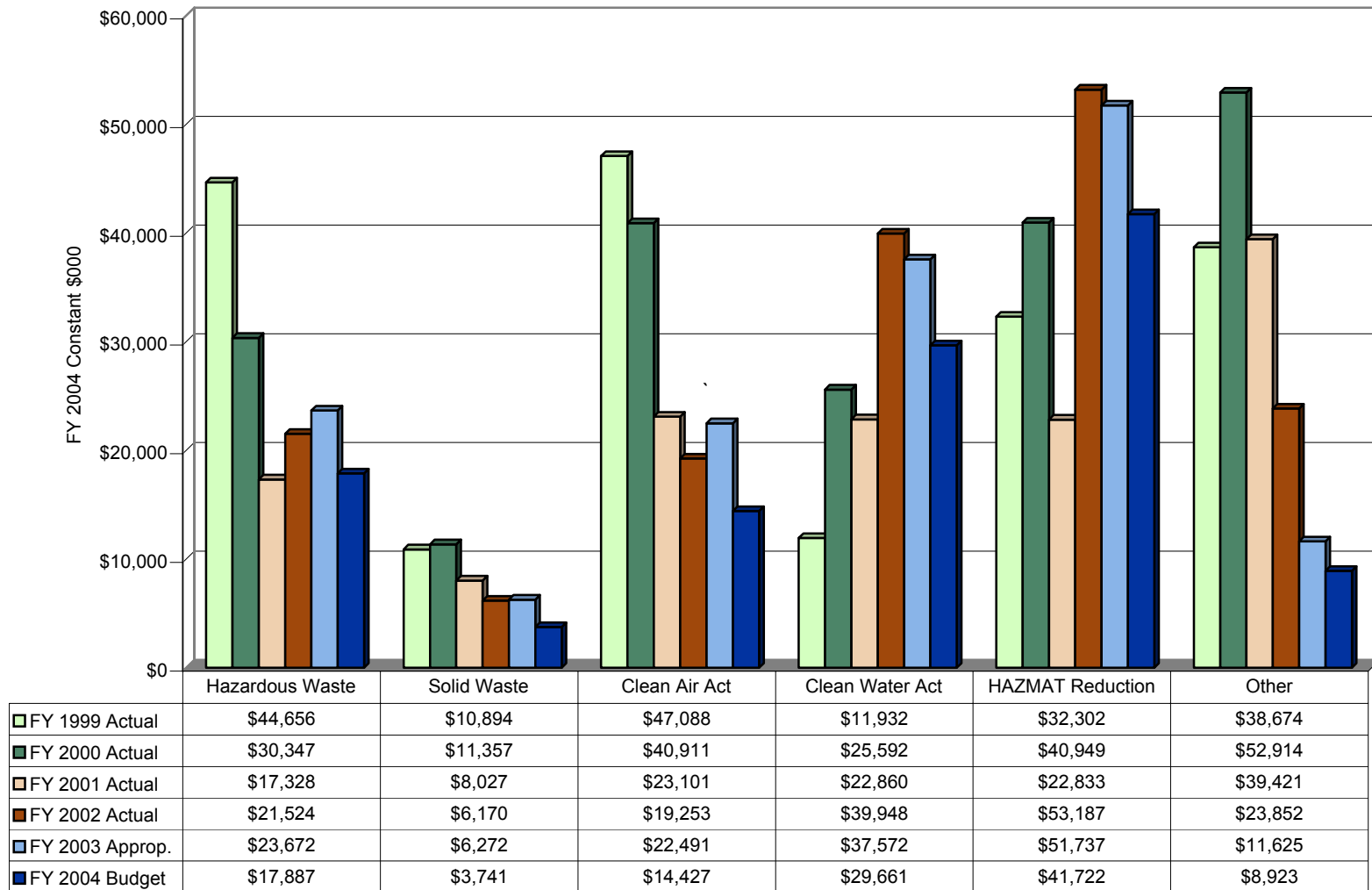
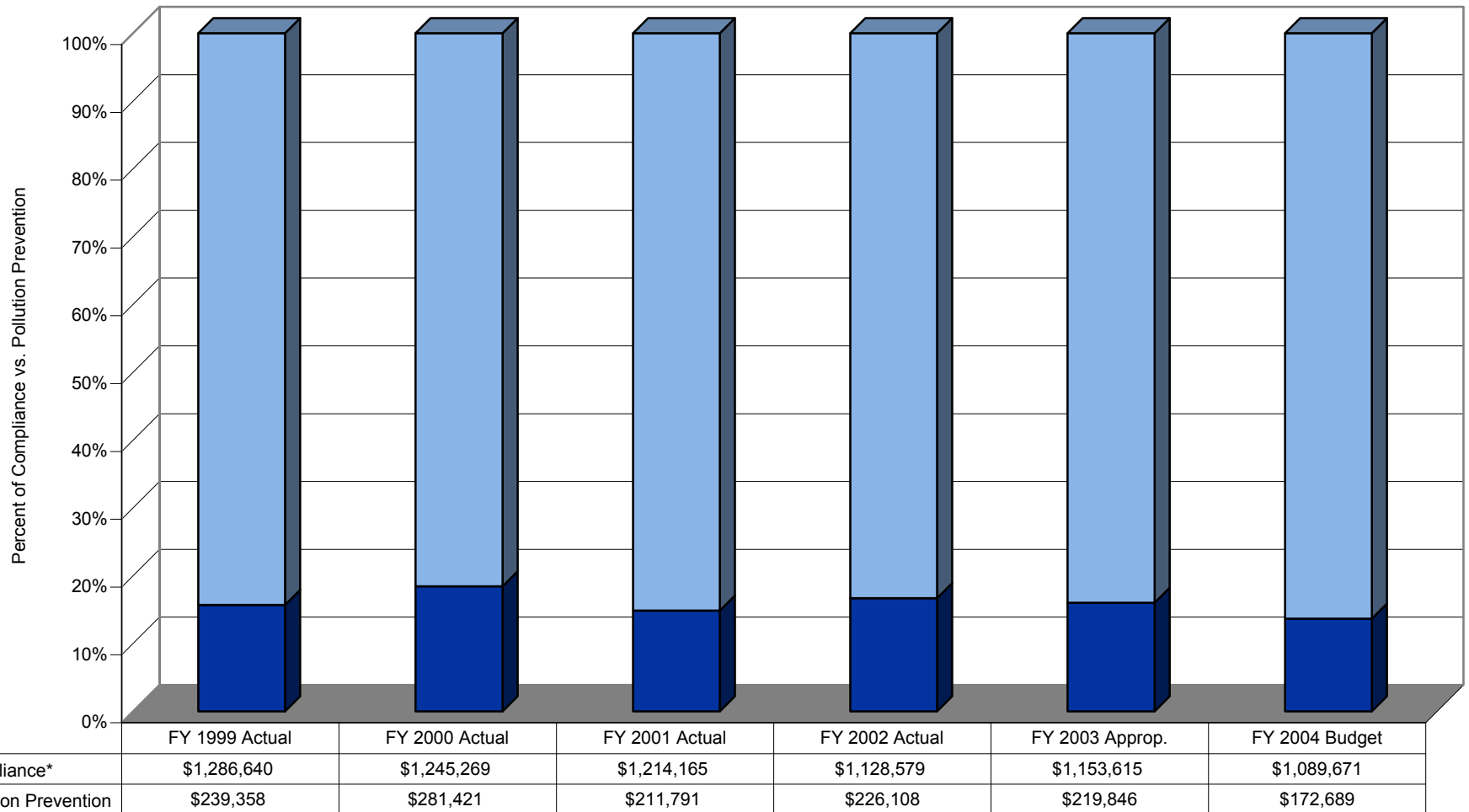
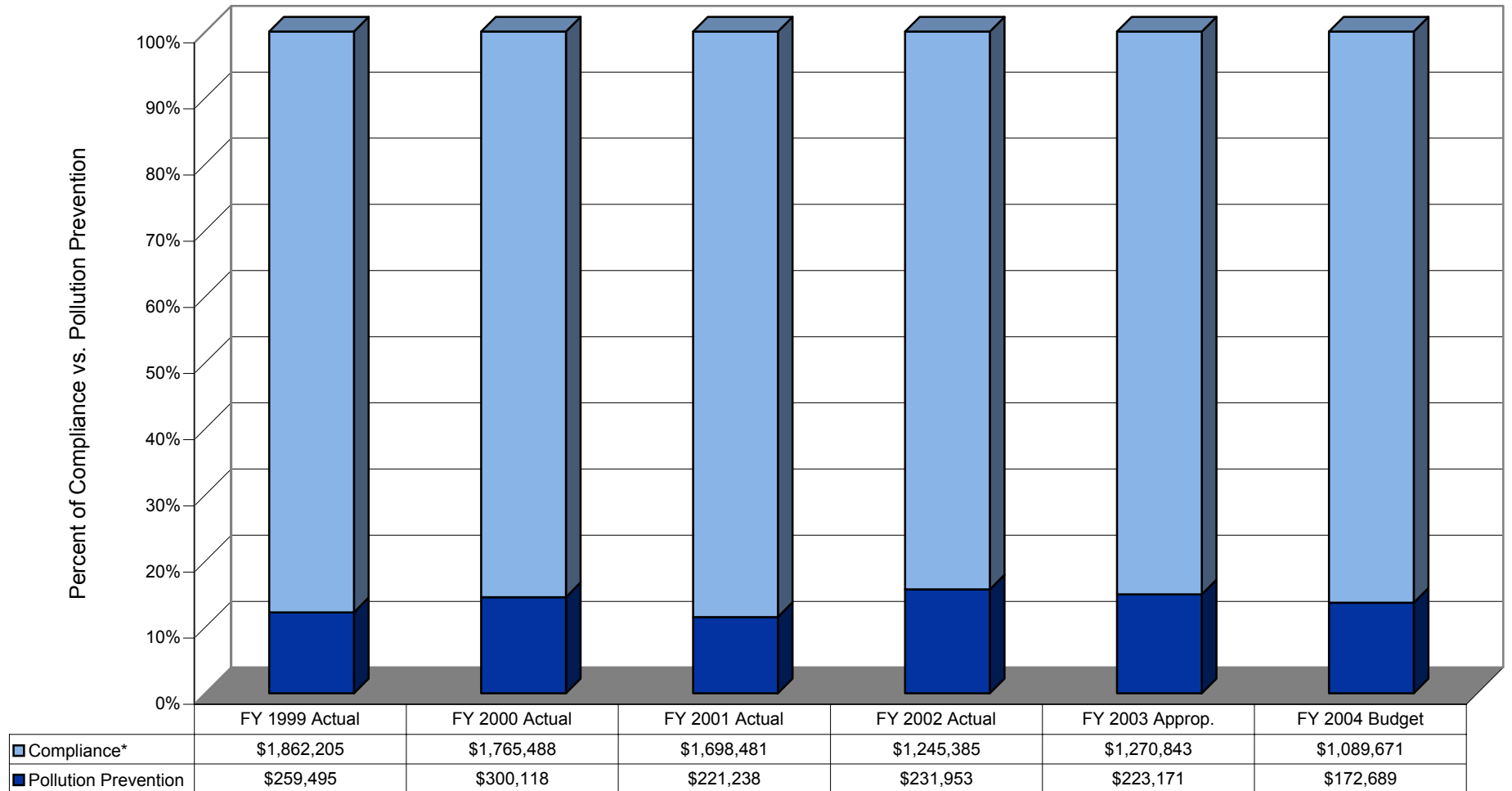

(Current \$000)

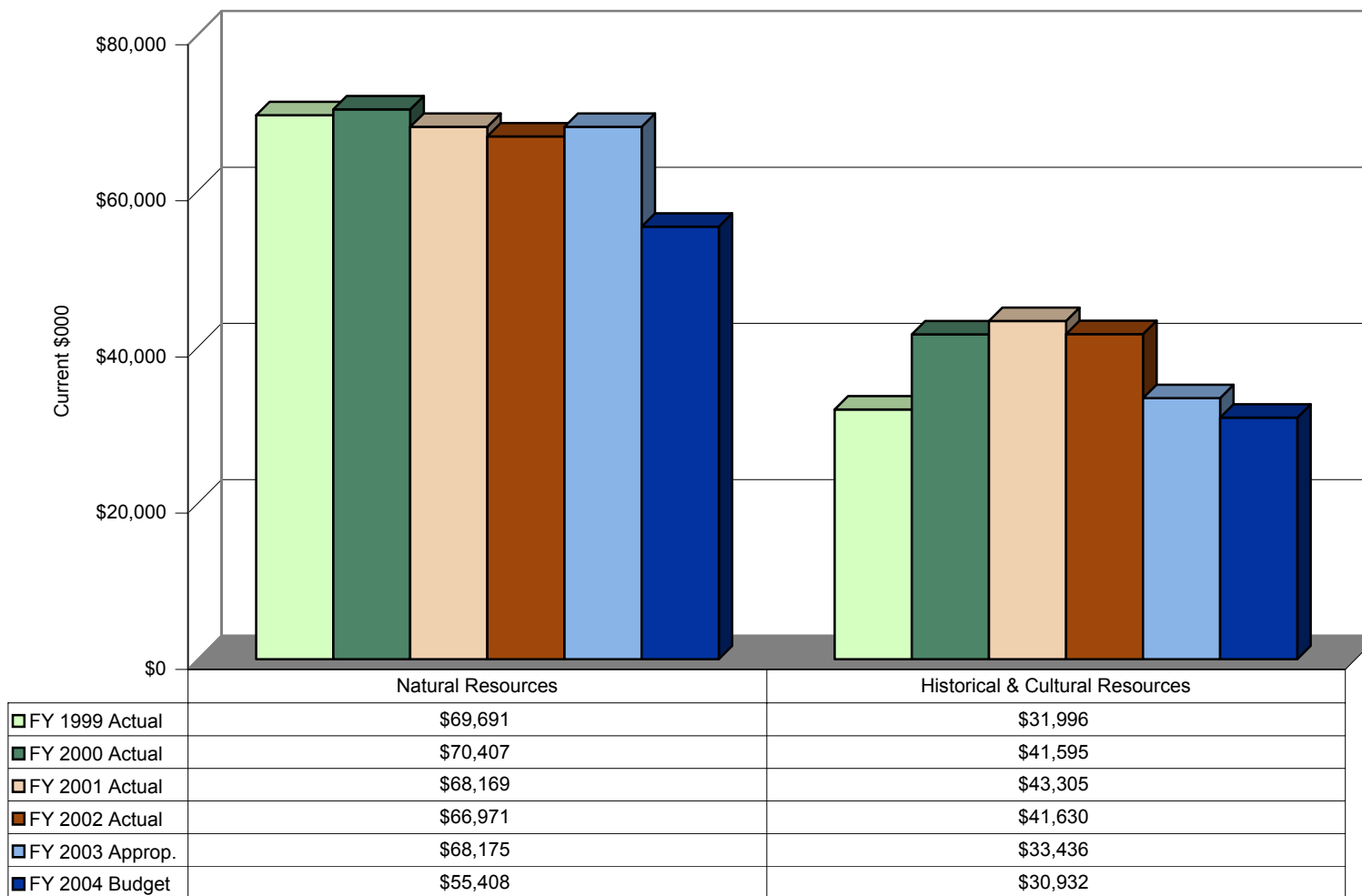

(FY 2004 Constant \$000)

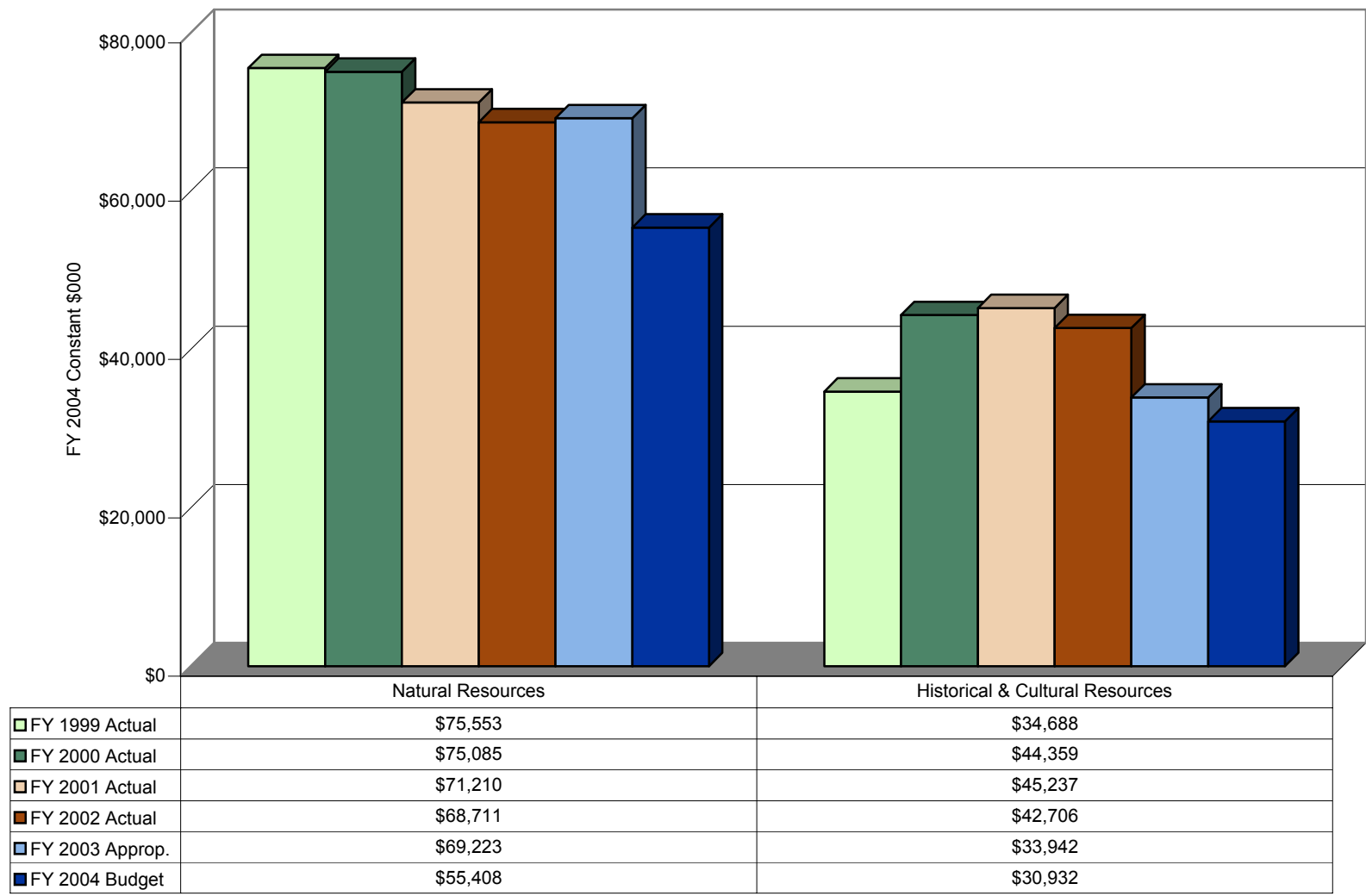

(Current \$000)

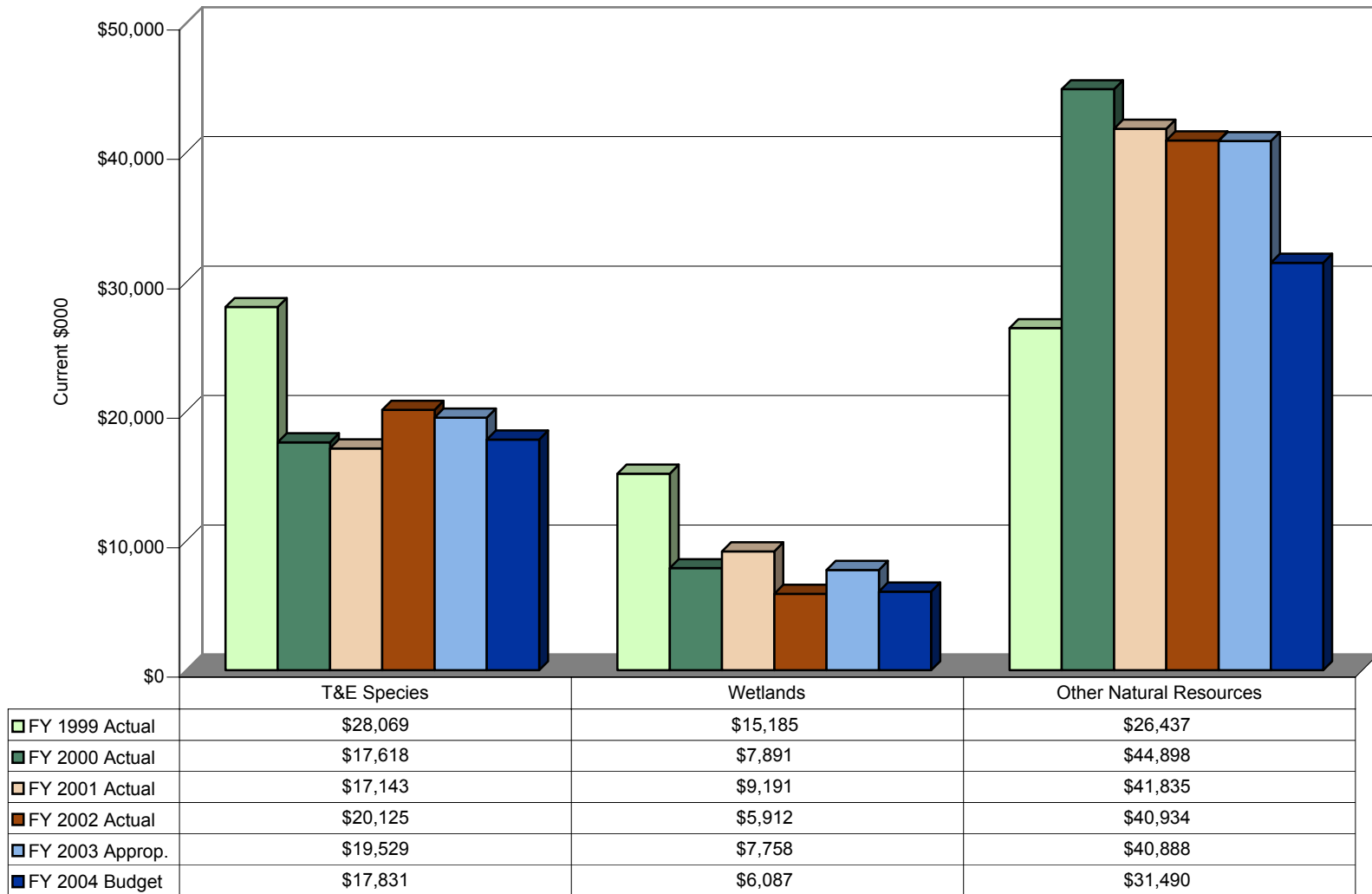

(FY 2004 Constant \$000)

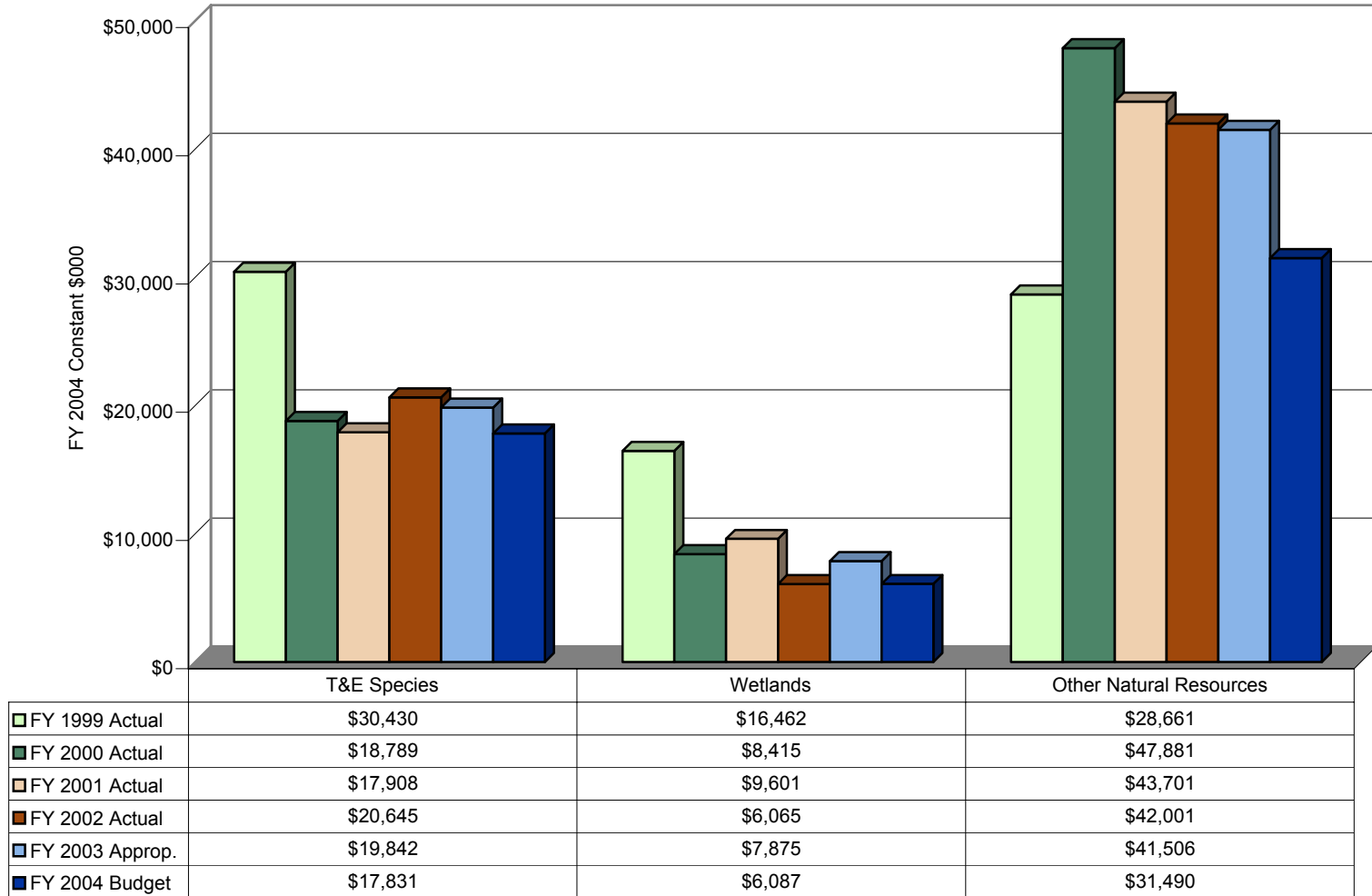

(Current \$000)

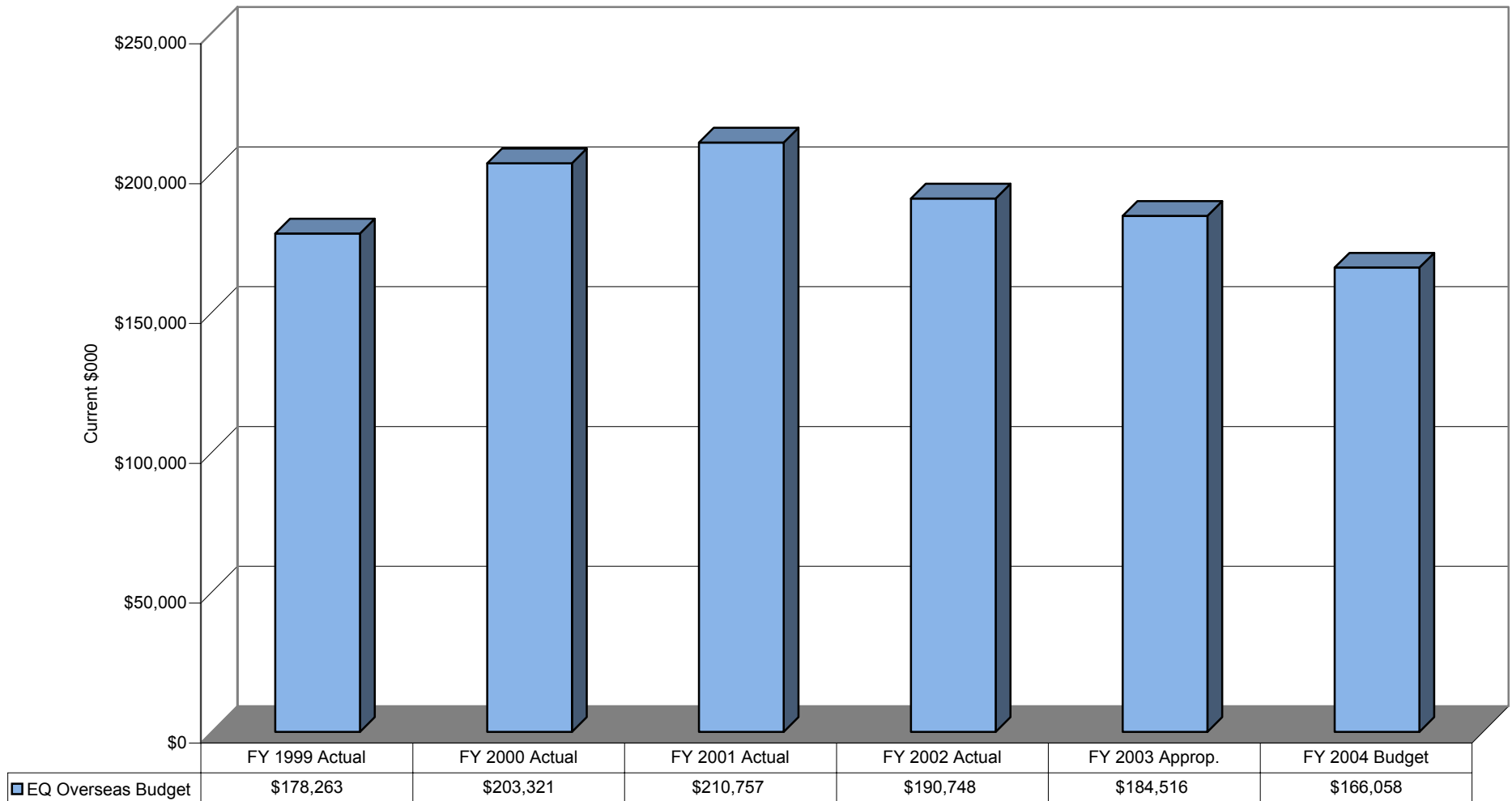
