Dear Mr. Fowler:

I am writing to notify you of the Department of the Army's intent to request a *Program Comment for Army Inter-War Era Historic Housing 1919-1940* pursuant to 36 CFR 800.14 (e). As discussed in our meeting on September 18, 2019, this Program Comment for Army Inter-War Era Historic Housing will address critical issues that directly affect the quality of life, health, and safety of military families that live in this historic housing.

The intent of the Program Comment is to improve the quality of life, health, and safety of the military families, increase property management efficiency and effectiveness, and preserve the historical and architectural character of this housing by meeting our National Historic Preservation Act (NHPA) Section 106 requirement in a programmatic manner. The Army believes a Program Comment is the best NHPA compliance solution for this category of historic property.

The Program Comment issued by the Council for Army Capehart-Wherry Housing 1949-1962 is the precedent for addressing the Army's large inventory of historic housing. Similar to Capehart-Wherry, Army Inter-War Era housing 1919-1940 represents a large inventory of similar historic property types with 2,709 housing units generally defined as a simplified Colonial Revival style with two variants (Georgian and Spanish), on 35 Army installations. Construction of this housing followed standardized plans adopted from civilian architectural designs and such Colonial Revival style housing is commonplace in the civilian sector.

Army Inter-War Era housing is subject to a large number of frequent and repetitive undertakings. Similar to the Capehart-Wherry Program Comment, the category of undertaking for the Army Inter-War Era Historic Housing Program Comment is

*management actions: maintenance, repair, rehabilitation, renovation, mothballing, demolition, replacement, transfer, sale, and lease.* These actions present a potential for adverse effects.

The Army's proposed Program Comment treatment measures for Army Inter-War Era historic housing will ensure the effects of our management actions are taken into account. The proposed treatment measures include a revised and expanded Army Inter-War Era Housing historic context that will provide a significant contribution to architectural history scholarship. The context will also help identify any Army Inter-War Era historic housing that may be of particular importance and warrant additional preservation measures. The Army will develop Design Guidelines for Army Inter-War Era Historic Housing 1919-1940 to identify the design elements that define the historical and architectural character of the housing and its setting. In order to address the health and safety risks to military families living in historic housing from potential hazards such as lead-based paint and to address the high costs associated with use of "in-kind" materials, the Army will implement its management actions using modern industry standard and imitative materials that closely match defining design elements identified in the Design Guidelines. The Army will develop public educational materials and distribute those materials via social media and other means. The Army will also monitor implementation of the Program Comment treatment measures to ensure effectiveness.

The Army's timeline for the Program Comment for Inter-War Era Historic Army Housing 1919-1940 begins with this notification of our intent. In October, we are planning to publish a Federal Register notice and issue a Press Release notifying the public of this action. We will also directly contact stakeholders including the National Trust for Historic Preservation, the National Conference of State Historic Preservation Officers, and the National Association of Tribal Historic Preservation Officers to initiate consultation. The Army intends to make its formal request for Program Comment to the Council in July 2020.
