ANNOUNCING

DoD Historic Buildings Conference Kansas City, Missouri-- June 2008



The Legacy funded conference is designed to provide cultural resources managers, architectural historians, historic architects, and their contractors—all of us who have oversight on DoD historic buildings—an overview of key themes in identifying, evaluating, and managing the vast number of historic buildings on our installations. Topics covered in the conference will be design guidelines, antiterrorism and force protection (ATFP), green buildings, sustainability, adaptive reuse strategies, and a variety of other essential topics. There will be a field trip for all participants to Fort Leavenworth, Kansas exemplifying ideas and issues discussed throughout the conference. Posters will be presented during the box lunch periods on Tuesday and Wednesday. The Keynote Speaker will be Mr. Alex Beehler, Assistant Deputy Under Secretary of Defense for Environment, Safety and Occupational Health.

The **no fee** conference will run from Tuesday 17 June to Thursday 19 June. On Monday 16 June will be two courses requiring fees—an Advanced Section 106 course taught by the Advisory Council (limit of 25 people) and an ATFP short course taught by the Center of Expertise in Omaha (limit of 50-75 people). Conference website with agenda and other information will be operational shortly, please look for further details in next month's Legacy newsletter.

Continental breakfasts, breaks, and box lunches will be provided each day. The conference will be held at the Kansas City Airport Hilton; for government rate please contact the hotel directly, and make reservations under "DoD Historic Buildings Conference."

NATIVE AMERICAN COINS

The US Treasury recently announced the release of \$1 coins featuring important achievements and people made by Native American tribes and individuals. One coin from the Native American Coin Program will be minted each year beginning in 2009 and released with the four Presidential \$1 coins. The program will continue until 2016.

The front of the \$1 Native American coins will feature the Sacagawea image released in 2000, with the person or Tribe image on the reverse. NEW WORKING GROUP FROM NMFWA

The National Military Fish and Wildlife Association (NMFWA) Board of Directors has conditionally-approved formation of a Conservation Law Enforcement Working Group (CLEWG) pending development of a charter and bylaws. The first CLEWG meeting will be held during the next NMFWA conference in Phoenix, 24-28 March 2008. Working Group meetings begin Monday afternoon (March 24). The meeting will establish rules of engagement/bylaws; present the draft Charter (Attachment); and discuss ongoing law enforcement issues/initiatives across DoD. FREE ONLINE TRAINING AVAILABLE FROM ACHP

The ACHP is very proud to announce the availability of an online training course for federal employees called, "Working Effectively with Tribal Governments." For a limited time, it will be available to the public free of charge.

While the one-hour training is geared towards federal employees, we encourage all our preservation partners to take the training to better understand the relationship federal agencies have to Indian tribes and the legal requirements that might impact the Section 106 review process. We also encourage you to pass along the URL to those you think might benefit from such training. It will be available to the public until April 30, 2008, at www.GoLearn.gov. Once at the GoLearn web site, click

on the small thumbnail to go to the tribal training. The training program was developed by a sub-group of the Indian Affairs Executive Working Group, established by the White House Office of Intergovernmental Affairs in 2006. Monique Fordham of the ACHP was one of the principle architects of this training and worked with federal partners from the Environmental Protection Agency and the Department of Justice.

NOTE: This one takes some time, but comes highly recommended. On a cold winter day after taking care of Colorado cattle or herding sheep, this recipe is sure to hit the spot!



PLAINS RECIPE: Cowboy Beef and Black Been Chili

RECIPE

2 lbs.	ground beef	¹/₂ c.	chili powder	1 can	diced tomatoes (14 oz
1 tbsp.	C	1 tbsp.	ground cumin	1 can	beef broth (14 oz)
1 ½ c.	chopped onions	1 tsp.	dried oregano	12 oz	dark beer
2 tbsp.	minced garlic	1 tsp	dried thyme	1/3 c.	tomato paste
2	chopped bell peppers	1/8 tsp	ground red pepper	2 cans	black beans (15 oz)
1 large	jalapeño pepper	1 can	crushed tomatoes (28 oz)	1 tbsp	honey

DIRECTIONS

Brown ground beef in stockpot over medium heat. Pour off drippings. Set beef aside in bowl. Heat oil in same pot until hot. Sauté onions and garlic until tender, add bell and jalapeno pepper until tender. Return beef to stockpot. Add seasonings, stir and cook for 2 minutes. Stir in tomatoes, broth, beer, tomato paste, and honey. Bring mixture to a boil. Cover, reduce heat to a simmer for 45 minutes. Uncover pot and continue simmering for 30 minutes, or until thickened to desired constancy. Stir in beans and cook until heated through. Season with salt and pepper to taste. Garnish with cilantro, cheddar cheese, sour cream as desired.
