

SPOTLIGHT STORY

Recycled Christmas trees at JEBLCFS prevent beach Erosion

Volunteers from across Joint Expeditionary Base Little Creek-Fort Story came together for a cold, blustery day at the beach Jan. 11, 2024.

They weren't there for a picnic or game of volleyball; their mission was to protect the dunes that enable training, recreation, and wildlife on Little Creek and Fort Story beaches. They were also keeping piles of discarded Christmas trees out of landfills by using them to shore up the dunes and prevent beach erosion.

The dunes are an essential natural feature that provides a barrier against erosion, said Dylan Freeman, JEBLCFS's natural resources officer. "It works similar to sand fencing in that it blocks the wind, and the branches and needles collect the sand."

The natural resources staff monitors the integrity of the dunes on the installation regularly. Dunes damaged by human activity, storm surges and high winds are designated for the annual restoration project, now in its 17th year. Past restoration efforts have proven very successful.

Carefully placing the trees along the dunes is the culmination of an annual project that begins right after Christmas. Service members and civilian staff are encouraged to bring their trees to collection locations. Community members and local tree retailers also donate.

Freeman said healthy dunes provide important ecosystems for shore birds and other animals, but they also protect the beaches that allow expeditionary and special warfare units to conduct training in a realistic environment so their skills stay sharp. This project is what "allows the Navy, Army and Marine Corps to continue conduct training on our beaches," he said.

Recent Postings of Broadly Applicable Alternative Test Methods: The U.S. Environmental Protection Agency (EPA) is announcing the broadly applicable alternative test method approval decisions in support of New Source Performance Standards (NSPS) and National Emission Standards for Hazardous Air Pollutants (NESHAP) in the year 2023. Source owners and operators may voluntarily use the broadly applicable alternative test methods in lieu of otherwise required test method or related testing procedures. The five approved alternative test methods are for the following:

- EPA Method 3A as an alternative to EPA Method 3B
- Certification of candidate Method 9 observers through use of a virtual reality headset
- EPA Method 3A as an alternative method for EPA Method 3B integrated bag analysis
- ASTM E-2515 filter gravimetric pre/post-test filter mass assessments per method direction in section 9.4.4.
- ASTM E-2515 dilution tunnel minimum velocity requirement as stated in section 9.2.1.

New Compliance Advisory for Federal Facilities: The EPA has published a new compliance advisory titled Federal Facility Compliance with the Asbestos NESHAP. The Asbestos NESHAP requirements protect the public by minimizing the release of asbestos fibers during building renovations and demolitions. This compliance advisory reminds federal facilities of their compliance obligations under the Asbestos NESHAP and the Clean Air Act (CAA) during building renovations and demolitions, even when those activities are performed by contractors.

Hazardous Waste Portal: This portal is intended to help generators find hazardous waste compliance assistance resources. The portal includes both federal and state information and it covers most industrial and commercial business sectors. The portal catalogs over 800 hazardous waste compliance resources, including guidebooks, fact sheets, reports, checklists, web sites, contacts, and regulations. WATER

Expedited Approval of Alternative Test Procedures for the Analysis of Contaminants under the Safe Drinking Water Act; Analysis and Sampling Procedures: This action announces the EPA's approval of alternative testing methods for use in measuring the levels of contaminants in drinking water to determine compliance with national primary drinking water regulations. The Safe Drinking Water Act (SDWA) authorizes EPA to approve the use of alternative testing methods through publication in the Federal Register. EPA is using this streamlined authority to make 93 additional methods available for analyzing drinking water samples. This expedited approach provides public water systems, laboratories, and primacy agencies with more timely access to new measurement techniques and greater flexibility in the selection of analytical methods, thereby reducing monitoring costs while maintaining public health protection. This action was effective Jan. 30, 2024.

Rhode Island HB 7439: This act is related to PFAS in drinking water, groundwater, and surface water.

Rhode Island HB 7619: This act would update the existing Toxic Packaging Act by delaying the ban on PFAS in processing agents, until July 1, 2027, and also expands the law by banning PVC and polystyrene in packaging.

Rhode Island SB 2152: This act would enact the Comprehensive PFAS ban act of 2024, prohibiting the intentional addition of PFAS in products offered for sale or manufactured in the state as of Jan. 1, 2027.

Rhode Island SB 2292: This act would establish the first green justice zone, a model that may be replicated in future years to ensure that all communities throughout the state have clean air and clean water.

FINAL REGULATION

Rhode Island Operation of Air Pollution Control Systems: The Department of Environmental Management Office of Air Resources has adopted rulemaking to remove language allowing variances for excess emissions during malfunctions. Specifically RIDEMOAR is proposing to remove § 16.3 which currently allows sources to petition for a variance from air pollution control requirements in the event of a malfunction of its air pollution control that is expected to last more than 24 hours. Effective Feb. 18, 2024.

FINAL REGULATION

District of Columbia Battery Stewardship Infractions: The Department of Energy and Environment has adopted amendments to Chapter 40 (Department of the Environment (DDOE) Infractions) of Title 16 (Consumers, Commercial Practices, and Civil Infractions). This rulemaking will schedule fines for violation of rules related to battery stewardship in Chapter 39 (Battery Stewardship) of Title 20 (Environment) of the DCMR. The rulemaking reflects amendments incorporated into the Sustainable Solid Waste Management Amendment Act of 2014 by the Battery and Electronic Stewardship Amendment Act of 2022, effective March 10, 2023 (D.C. Illinois HB 4639 (SB 2960): This act provides that, beginning July 1, 2025, hotels with 50 rooms or more and, beginning Jan. 1, 2026, hotels with less than 50 rooms may not provide small single-use plastic bottles containing personal care products to either (i) a customer of the establishment who is staying in a sleeping room accommodation or any space within the sleeping room accommodation or (ii) a customer of the establishment who is using a bathroom shared by the public or guests.

Effective March, 28, 2024.
