### SPOTLIGHT STORY

#### Management Standards for Hazardous Waste Pharmaceuticals and Amendment to the P075 Listing for Nicotine

On 22 February 2019, the Environmental Protection Agency (EPA) published the final rule for the Management Standards for Hazardous Waste Pharmaceuticals and Amendment to the P075 Listing for Nicotine. The rule, signed on 11 December 2018, is the culmination of numerous iterations by EPA to formalize a regulatory program for hazardous waste pharmaceuticals. EPA has created new regulations, including clarification to numerous terms, in 40 CFR Part 266 Subpart P for the management of hazardous waste pharmaceuticals by healthcare facilities and reverse distributors.

EPA has stated the goals of the final rule are to:

- Create regulations that are a better fit for the healthcare sector for the management of hazardous waste pharmaceuticals including “Resource Conservation and Recovery Act (RCRA) empty” container standards
- Eliminate the intentional sewerage of hazardous waste pharmaceuticals
- Reduce overlapping regulations with federal departments such as the Food and Drug Administration (FDA) and the Drug Enforcement Agency (DEA)
- Provide regulatory clarity and national consistency on how RCRA applies to reverse distribution and reverse logistics activities
- Provide regulatory relief to healthcare facilities that are regulated as large quantity generators when generating small amounts of nicotine replacement therapy waste.

The effective date of the rule will be 21 August 2019 and will be effective in non-authorized states, Indian country and US territories excluding Guam on that date. The sewerage prohibition will be effective in all states on 21 August 2019, regardless of whether the state is authorized or has adopted Subpart P. States have until 1 July 2021 to adopt the rule.

The final rule also provides for an amendment to the P075 listing for Nicotine. FDA approved over-the-counter nicotine replacement patches, gums, and lozenges will no longer be included in the P075 listing for hazardous waste. Other unused formulations of nicotine will still carry the P075 hazardous waste code when discarded.

# WATER

**Senate Bill 675 Prompt and Fast Action to Stop Damages Act of 2019 (Draft) (Added 03/20/2019)** A bill to authorize the Department of Defense to temporarily provide water uncontaminated with perfluorooctanoic acid (PFOA) and perfluorooctane sulfonate (PFOS) for agricultural purposes to areas affected by contamination from military installations, and to authorize the Secretary of the Air Force to acquire real property to extend the contiguous geographic footprint of any Air Force base that has shown signs of contamination from PFOA and PFOS due to activities on the base.

# AIR

**Emissions Monitoring Provisions in State Implementation Plans** EPA has revised some of the regulations that were originally promulgated in 1998 to implement the nitrogen oxide (NOX) state implementation plan (SIP) Call. The revisions give covered states greater flexibility concerning the form of the NOX emission monitoring requirements that the States must include in their SIPs for certain emissions sources.

The group of units affected under the SIPs adopted to meet the NOX SIP Call comprises both existing and new electricity generating units (EGUs) as well as certain other existing and new industrial units (non-EGUs).

Within this overall group, the set of existing units potentially affected by the amendment includes approximately 285 non-EGU boilers and combustion turbines and approximately 30 EGUs—specifically, combustion turbines that are considered large EGUs for NOX SIP Call purposes and that are not required to monitor according to part 75 under other programs such as the Acid Rain Program or a Cross-State Air Pollution Rule (CSAPR) trading program. The States, not EPA, will decide whether to revise the monitoring requirements in their SIPs as allowed.

Examples of industries with potentially affected sources include:

- Fossil fuel-fired electric power generation.
- Grain and oilseed milling.
- Pulp, paper, and paperboard mills.
- Petroleum and coal products manufacturing.
- Basic chemical manufacturing.
- Iron and steel mills and ferroalloy manufacturing.
- Colleges, universities, and professional schools.

## PENNSYLVANIA

### ***PROPOSED LEGISLATION***

**House Bill 674** amends the act of May 1, 1984 (P.L.206, No.43), known as the Pennsylvania Safe Drinking Water Act (SDWA), providing for maximum contaminant levels for two per- and polyfluoroalkyl substances (PFAS) at 5 parts per trillion. **House Bill 675** amends the act of October 18, 1988 (P.L.756, No.108), known as the Hazardous Sites Cleanup Act, in preliminary provisions, further providing for definitions. This bill amends the Pennsylvania hazardous substance definition by including perfluorooctanoic acid (PFOA) and perfluorooctane sulfonate (PFOS) at the EPA health advisory level.

## VIRGINIA

**House Bill 2403** requires the State Water Control Board to evaluate Virginia Water Protection Permits mitigation options for impacts to wetlands on a case-by-case basis with consideration for which option is practicable and ecologically and environmentally preferable, including, in terms of replacement of acreage and functions, whichever option has the greatest likelihood of success and avoidance of temporal loss of acreage and function.

## WEST VIRGINIA

### **PROPOSED LEGISLATION**

**State Bill 430** existing public water utility that draws and treats water from a surface water supply source or a surface water influenced groundwater supply source shall submit to the commissioner an updated or completed Source Water protection plan for each of its public water system plants with such intakes to protect its public water supplies from contamination. Every effort shall be made to inform and engage the public, local governments, local emergency planners, local health departments, and affected residents at all levels of the development of the protection plan.

### ILLINOIS

**House Bill 2318** amends the Illinois Vehicle Code. Provides that local authorities, with respect to highways under their jurisdiction, may limit the operation of trucks or other commercial vehicles in areas with poor air quality.

**State Bill 2318** creates the Reduction of Lead Service Lines Act. Requires community water supplies to identify and replace all lead service lines that connect to a water main. Provides that every community water supply in Illinois that has known lead service lines shall create a plan, to be submitted to the EPA for approval, to replace all lead service lines and galvanized service lines if the service line is or was connected to lead piping.

### INDIANA

#### **PROPOSED LEGISLATION**

**House Bill 1648** establishes a tax credit for taxpayers that establish clean energy training positions to provide training in technology involving solar, wind energy, or geothermal energy facilities and equipment. Requires the owner or operator of an above ground storage tank (AST) that is designed to contain more than 660 gallons of liquid to report certain information about the AST to the department of environmental management before 1 January 2020.
